## → Introduction

Philippe Pilate welcomes everybody

He reminds the Class' main goals and objectives which are to federate boat owners, to encourage dynamism and to raise the level of the fleet by organizing the HTCC.

- → Bert starts the meeting presentation by displaying a power point
  - \* Legally the HTCE is an 'asbl' or association without profit motives, as per Belgian's regulations, and has its legal and financial address in Belgium It has a board formed by Philippe /President, Bert/Secretary, and Laurent Vancutsem/Treasurer. Up until today's meeting the association has no members (in its legal form) but this changes with the present meeting.
  - \* The assembly approves the 2019 meeting minutes (no remarks).

- \* Many new boat re-building projects, a.o. ALFonce in Nieuwpoort, Alpha Jet in France, ...
- \* New active boats in France with a.o. Domino's Pizza (Paul Meilhat) and Diablesse (Nicolas Lunven)

→ 2022 perspectives: For next year (= the 2022 general assembly) the class hopes to be able to present more dates of local ½ ton regattas (Italy – France – Norway – Holland – Ireland – UK - ...)

#### → HTCC in Cowes :

19-23 JUL 2021 / RORC - Cowes / Isle of Wight

Due to Covid19 there are major uncertainties about the smooth running of the HTCC. On the one hand the RORC can still cancel (decision at the end of March) and on the other hand, if the HTCC is maintained, it is likely that social events will be restricted. In that case the Class will decide to postpone the race for an extra year (final decision end of April 2020), considering a HTCC without social life is not a HTCC...

- → The meeting agrees that next HTCC should remain in Cowes, even if it has to be in 2022 or 2023.
- → President Philippe proposes that the HTCC is to be organised annually again, in order to give the growing fleet more racing perspectives. The proposal is discussed by the assembly and the trend goes in the same direction.
- → Since the HTC of Norway is willing to organize an HTCC (2023) a member asked if any Norwegian boat will attend the Cowes HTCC. Reply is « YES, they have promised to come »
- → HTCE Actions in 2021 :
  - \* Try to sail a bit more than last year...
  - \* Managing/evolutions of Class' website
  - \* Co-organize the 2021 HTCC in Cowes
  - \* Find sponsors
  - \* IRC measurer training (to be continued...)
- → HTCE Membership fees:
  - \* As discussed during the budget presentation the time has come to structure the Class memberships: this is essential for the survival and good management of the Class.

    Membership fees will be used to cover website costs, media and P/R function during HTCC (big amount), and other costs of HTCE promotion, video's etc...

In short: every action esteemed necessary to maintain the attractiveness and reputation of the class as well as its international visibility.

## Also:

Membership fees will enhance class' feeling

All paid members will have certain advantages, like:

- better presentation of their boat on the website
- more Class' newsletters
- a voice/vote in the annual AGM's, and hence in the Class' life & future (for full members
   1 per boat)

The Class' board proposes:

- 50,- €/year membership fee for boat owners as «full members» (note 2)
- 10,- €/ year membership fee for active crews as « supporting members » (note 3)

(Note 2: Only full members can vote at general assemblies.)

(Note 3: Crew members on official HTCE regatta must be members)

#### → HTCE board of Directors :

HTCE board is now composed as follows:

Laurent Vancutsem – treasurer

Bert Janssen – secretary

Dave Cullen – senior advisor

The current board proposes to renew the mandate of the first 3, the 4th one being 'for life'... The assembly approves!

Since it is important to have one Class leader in every country having HT activities, Paul Browning applies to represent the Class in the U.K., which is evidently approved.

The Class will be governed by the board for the daily management (Note 4), a larger commission including the board members and country representatives will discuss the board's proposals before these are made public.

(Note 4: President, Secretary, Treasurer, senior advisor).

→ Bert closes the meeting at 12:12 by thanking the participants and wishing the best for 2021. As conclusion Philippe adds: "the diversity in the fleet is great but we are close (same goes for our boat speeds ⑤) Collective intelligence can make the Class stronger and the Class is yours."
